The purpose of this modification is to do the following:

1. To exercise Option Period One (1), in accordance with (IAW) modification P00027 dated 23 January 2015, to extend the Period of Performance of contract W91QUZ-09-D-0043 for an additional one (1) month extension for the ordering of hardware, software, and services SLINs only (SLINs 1001AA through 1069AA) from 24 March 2015 through 23 April 2015. This extension will be incorporated into the contract at no additional cost to the Government.

As a result of this modification, both parties mutually agree to utilize the previously established pricing from Option Period One (1), IAW modification P00018 dated 20 July 2012, for SLINs 1001AA through 1069AA for a one (1) month period. This one (1) month option extension is not for the Maintenance SLINs as the Government exercised Option Period two (2) for four (4) years of maintenance (SLINs 2081AA through 2083BD) from 24 July 2014 to 23 July 2018 on 10 July 2014 via modification P00025.

2. Except as provided by this modification, all terms and conditions of this contract remain unchanged and in full force and effect throughout the one (1) month option extension.
