The purpose of this modification is to do the following:

1. To exercise the Government's unilateral right to exercise an Option in accordance with the contracts clause FAR 52.217-9, Option to Extend the Term of the Contract. The Government hereby exercises Option Period two (2) for four (4) years of maintenance (SLINs 2081AA through 2083BD) from 24 July 2014 to 23 July 2018.
2. To extend the Period of Performance of contract W91QUZ-09-D-0041 for an additional six (6) months for the ordering of hardware, software, and Technical Engineering Service (TES) to include SLINs 1001AA through 1069AA from 24 July 2014 to 23 January 2015. This extension will be incorporated into the contract at no additional cost to the Government. As a result of this modification, both parties mutually agree to utilize the previously established pricing from the option period one for SLINs 1001AA through 1069AA for the six month extension of this contract. This six month extension does not include the Maintenance SLINs as the Government is exercising Option Period 2 per paragraph 1 above for four (4) years of maintenance (SLINs 2081AA through 2083BD) from 24 July 2014 to 23 July 2018.
3. Except as provided by this modification, all terms and conditions of this contract remain unchanged and in full force and effect throughout the six month extension.
